Pursuant to LR 6-1 and LR 26-4, Non-Party Haines & Krieger, LLC (“H&K”) and Experian Information Solutions, Inc. (“Experian”), by and through their respective counsel of record, hereby move jointly and request that this Court extend Plaintiff’s deadline to file a reply in support of his motion for protective order. In support of the same, the parties state as follows:

On July 10, 2018, Experian noticed the deposition of H&K, one of the law firms representing Plaintiff Louis Cardinali, for July 30, 2018.

On July 18, 2018, H&K moved to quash Experian’s deposition subpoena on an emergency basis. ECF Dkt. 84, 85.

1 On July 18, 2018, the Court granted H&K's motion to vacate the then-pending deposition
2 date, and issued an order setting briefing on H&K's motion in the ordinary course. ECF Dkt. 86
3 (minutes).

4 On August 1, 2018, Experian responded to the motion. ECF Dkt. 87. Replies are presently
5 due on August 8, 2018.

6 Experian and H&K request that H&K be permitted an additional seven days to reply, until
7 August 15, 2018. This additional time will permit H&K time to review and respond to the
8 arguments set forth in the response. This is the first request for extension of the reply deadline, and
9 is made in good faith and not for purposes of delay.
