 19 On or about 1/13/2017, LIONEL LIBORIO JR. (the “Plaintiff”) and EXPERIAN
 20 INFORMATION SOLUTIONS, INC (the “Defendant” or “EXPERIAN”)(hereinafter
 21 collectively the “Settling Parties”) settled their respective disputes in this matter.

23 While dismissal paperwork has not yet been filed, the Settling Parties have
 24 negotiated the final terms of a proposed settlement agreement and the settlement terms
 25 are being executed.

1 The specific delays in filing dismissal paperwork resulted from a natural time
2 delay in finalizing agreeable credit reporting data to be reported on the Plaintiff's credit
3 report. The Settling Parties both had to consult with their clients to finalize the data
4 which was agreeable to be published by the Defendant. Accordingly, additional time
5 was required to finalize settlement and fulfill the Settling Parties' settlement obligations.

7 The Settling Parties expect to have all outstanding settlement issues resolved
8 within thirty (30) days.
