 24 Pursuant to LR IA 6-1 and LR 7-1, Plaintiff Navneet Sharda, M.D. (“Plaintiff”) and
 25 Defendants Sunrise Hospital and Medical Center, LLC, including its Board of Trustees (“Sunrise
 26 Hospital”), Susan Reisinger, M.D. (“Dr. Reisinger”), and Katherine Keeley, M.D., D.D.S. (“Dr.
 27 Keeley”) (collectively the “Sunrise Defendants”) hereby stipulate and agree as follows:

1 1. On December 30, 2016, the Sunrise Defendants filed their Motion to Dismiss. (*See*

3 2. On December 6, 2016, the Court granted the Parties' Stipulation and Order extending

7 ECF No. 46.)

9 Defendants to file their reply brief in support of their Motion to Dismiss from February 23, 2017 to
10 March 3, 2017. The reason for this request is to accommodate the schedules of counsel for the
11 Sunrise Defendants.


