**STIPULATION AND ORDER TO EXTEND
TIME FOR BANK OF AMERICA, N.A.
TO RESPOND TO ANTELOPE
HOMEOWNERS' ASSOCIATION'S
MOTION TO DISMISS AND ABSOLUTE
COLLECTION SERVICES, LLC'S
JOINDER**

[SECOND REQUEST]

16 Plaintiff Bank of America, N.A. (**BANA**) and defendants Antelope Homeowners Association
17 (**HOA**) and Absolute Collection Services, LLC (**ACS**) stipulate to extend the time for BANA to
18 respond to HOA's motion to dismiss and ACS' joinder of the same to September 28, 2018. (ECF Nos.
19 41 and 44)

20 1. BANA filed its complaint on September 28, 2016 asserting a quiet title/declaratory
21 judgment, breach of NRS 116.1113, and wrongful foreclosure against HOA and ACS. (ECF No. 1)

22 2. HOA filed a motion to dismiss BANA's complaint on October 28, 2016. (ECF No. 15).
23 BANA filed a response to HOA's motion to dismiss on November 14, 2016. (ECF No. 18)

24 3. The court entered an order staying this case pending exhaustion of all appeals of
25 Bourne Valley Court Trust v. Wells Fargo Bank, 832 F.3d 1154 (9th Cir. 2016) on March 9, 2017.

1 The order denied all pending motions, including HOA's motion to dismiss, without prejudice to refile
2 the motions after the stay is lifted. (ECF No. 26)

3 4. The court entered an order lifting the stay on July 20, 2018. (ECF No. 35)

4 5. The court entered a scheduling order setting the close of discovery for January 16, 2019
5 on August 8, 2018. (ECF No. 37)

6 6. HOA filed a motion to dismiss BANA's complaint on August 10, 2018. (ECF No. 41)
7 ACS filed a joinder to HOA's motion to dismiss on August 14, 2018. (ECF No. 44) BANA's response
8 to HOA's motion to dismiss and ACS's joinder is currently due by stipulation on September 7, 2018.
9 (ECF No. 48)

10 7. Due to the number of cases which have become unstayed as a result of the resolution of
11 the certified question, BANA wishes to have additional time to respond to HOA's motion to dismiss
12 and ACS's joinder.

13 8. The parties stipulate to extending BANA's deadline to respond to HOA's motion to
14 dismiss and ACS's joinder to September 28, 2018.


