**Order Adopting Report and  
Recommendation**

[ECF Nos. 9, 14, 15]

10 When plaintiff Chandrawattie Ikhiende was denied Social Security Disability Insurance  
11 and Supplemental Social Security benefits three times—twice by the Social Security  
12 Administration (SSA) and once by an administrative law judge (ALJ)—and the SSA Appeals  
13 Council denied review of the ALJ’s decision, she filed this appeal. Ikhiende moved for an order  
14 reversing the ALJ’s decision or, alternatively, remanding the case back to the ALJ.<sup>2</sup> The  
15 government filed a cross motion for summary judgment and opposed Ikhiende’s motion to  
16 reverse or remand.<sup>3</sup>

17 After reviewing both parties’ motions, Magistrate Judge Hoffman recommends that I  
18 deny Ikhiende’s motion, grant the government’s cross motion, and affirm the ALJ’s decision.<sup>4</sup>  
19 Judge Hoffman issued his recommendation on October 16, 2017, making October 30, 2017, the  
20 deadline to file objections. That deadline has passed, and no one has objected. “[N]o review is



1 required of a magistrate judge's report and recommendation unless objections are filed."<sup>5</sup>  
2 Accordingly, with good cause appearing and no reason to delay, IT IS HEREBY ORDERED that  
3 Magistrate Judge Hoffman's report and recommendation [ECF No. 15] is **ACCEPTED and**  
4 **ADOPTED**. Ikhiede's motion to remand [ECF No. 9] is **DENIED** and the government's cross  
5 motion to affirm [ECF No. 14] is **GRANTED**. The **Clerk of Court** is directed to **ENTER**  
6 **JUDGMENT** accordingly and **CLOSE THIS CASE**.
