ORDER

I. DISCUSSION

On October 17, 2017, the Court issued a screening order that dismissed some claims with leave to amend, dismissed other claims with prejudice, and permitted some claims to proceed. (ECF No. 5 at 12). The Court granted Plaintiff until November 17, 2017 to file an amended complaint curing the deficiencies of the complaint. (*Id.*). The Court specifically stated that if Plaintiff chose not to file an amended complaint, the action would proceed against Defendants Buencamino, Dreesen, Calderone, Maijoy, and Carrillo on Count I (deliberate indifference to serious medical needs) only. (*Id.* at 13). Plaintiff has not filed an amended complaint. Pursuant to the screening order, this action shall proceed against Defendants Buencamino, Dreesen, Calderone, Maijoy, and Carrillo on Count I (deliberate indifference to serious medical needs) only.

II. CONCLUSION

For the foregoing reasons, IT IS ORDERED that, pursuant to the Court’s screening order (ECF No. 5), this action shall proceed against Defendants Buencamino, Dreesen, Calderone, Maijoy, and Carrillo on Count I (deliberate indifference to serious medical needs) only.

1 IT IS FURTHER ORDERED that given the nature of the claim(s) that the Court has
2 permitted to proceed, this action is **STAYED** for ninety (90) days to allow Plaintiff and
3 Defendant(s) an opportunity to settle their dispute before an answer is filed or the discovery
4 process begins. During this ninety-day stay period, no other pleadings or papers shall be filed
5 in this case, and the parties shall not engage in any discovery. The Court will refer this case
6 to the Court's Inmate Early Mediation Program, and the Court will enter a subsequent order.
7 Regardless, on or before ninety (90) days from the date this order is entered, the Office of the
8 Attorney General shall file the report form attached to this order regarding the results of the
9 90-day stay, even if a stipulation for dismissal is entered prior to the end of the 90-day stay.
10 If the parties proceed with this action, the Court will then issue an order setting a date for
11 Defendants to file an answer or other response. Following the filing of an answer, the Court
12 will issue a scheduling order setting discovery and dispositive motion deadlines.

13 IT IS FURTHER ORDERED that "settlement" may or may not include payment of
14 money damages. It also may or may not include an agreement to resolve Plaintiff's issues
15 differently. A compromise agreement is one in which neither party is completely satisfied with
16 the result, but both have given something up and both have obtained something in return.

17 IT IS FURTHER ORDERED that if any party seeks to have this case excluded from the
18 inmate mediation program, that party shall file a "motion to exclude case from mediation" on
19 or before twenty-one (21) days from the date of this order. The responding party shall have
20 seven (7) days to file a response. No reply shall be filed. Thereafter, the Court will issue an
21 order, set the matter for hearing, or both.

22 IT IS FURTHER ORDERED that the Clerk of the Court shall electronically **SERVE** a
23 copy of this order and a copy of Plaintiff's complaint (ECF No. 6) on the Office of the Attorney
24 General of the State of Nevada, by adding the Attorney General of the State of Nevada to the
25 docket sheet. This does not indicate acceptance of service.

2 within twenty-one (21) days of the date of the entry of this order whether it will enter a limited
3 notice of appearance on behalf of Defendants for the purpose of settlement. No defenses or
4 objections, including lack of service, shall be waived as a result of the filing of the limited notice
5 of appearance.
