 18 **IT IS HEREBY STIPULATED AND AGREED BY AND BETWEEN**  
 19 Plaintiff/Counter-Defendant Great Western Air, LLC d/b/a Cirrus Aviation Services, LLC, and  
 20 Defendant/Counter-Claimant Cirrus Design Corporation by and through their undersigned  
 21 counsel, as follows:

22 1. On February 3, 2023, Defendant/Counter-Claimant Cirrus Design Corporation  
 23 filed a Motion to Amend or Add Findings and/or Rule 59 Motion for a New Trial [ECF No.  
 24 184].

25 2. The deadline for Plaintiff/Counter-Defendant Great Western Air, LLC d/b/a  
 26 Cirrus Aviation Services, LLC to respond to Defendant Counter-Claimant Cirrus Design  
 27 Corporation’s motion is February 17, 2023. The deadline for Defendant/Counter-Claimant  
 28 Cirrus Design Corporation to file a reply is February 24, 2023.

1           3.     The parties have agreed to extend the deadlines for Plaintiff/Counter-Defendant  
2 Great Western Air, LLC d/b/a Cirrus Aviation Services, LLC to respond to Defendant/Counter-  
3 Plaintiff Cirrus Design Corporation's Rule 52 Motion to Amend or Add Findings and/or Rule  
4 59 Motion for a New Trial and for Defendant/Counter-Claimant Cirrus Design Corporation to  
5 reply.

6           4.     The parties have agreed that Plaintiff/Counter-Defendant Great Western Air, LLC

15 prejudice any party.
