13 Magistrate Judge Nancy J. Koppe. IT IS FURTHER ORDERED that the Clerk of
14 Court is directed to consolidate Case No. 2:17-cv-02641-RFB-GWF with Case Nos.
15 2:16-cv-02525-MMD-NJK, 2:16-cv- 02562-MMD-NJK, and 2:16-cv-02658-MMD-NJK,
16 and all future pleadings must bear Case No. 2:16-cv-02525-MMD-NJK.¹
