1 (“Defendants”), and files this Motion to Withdraw as Counsel for Defendants pursuant to

4 1) This matter has been submitted by Aargon Agency, Inc. to its insurance  
5 carrier, and the law firm of Carlson & Messer, LLP was retained by the insurance carrier  
6 to represent Defendants.

8 2) The law firm of Lincoln, Gustafson & Cercos LLP will stay on as local  
9 counsel in this case.

11 3) Defendants recently filed a Motion to Consolidate this lawsuit with ten other  
12 related lawsuits filed in this district. Carlson & Messer will file a *pro hac vice* motion into

16 Gustafson & Cercos, LLP will remain as counsel in all 11 cases.

18 4) At this point, no specific delay in a deadline will result from the Withdrawal.

20 5) Good cause is present in this case to grant the withdrawal, due to the  
21 Defendants’ insurance carrier retaining Carlson & Messer LLP to defend Defendants.
