16 IT IS HEREBY ORDERED that any opposition to Plaintiff's Motion to Stay All Discovery and
17 Pretrial Deadlines Until the District Court Rules Upon Plaintiff's Pending Dispositive Motion (ECF No.
18 132) must be filed on or before noon, September 29, 2017. No reply necessary.

19 IT IS FURTHER ORDERED that a hearing on Plaintiff's Motion to Stay All Discovery and
20 Pretrial Deadlines Until the District Court Rules Upon Plaintiff's Pending Dispositive Motion (ECF No.
21 132) is scheduled for 10:00 AM, October 2, 2017, in Courtroom 3D.

22 Pursuant to LR IC 2-2(g), unless the presiding judge orders otherwise, a filer must provide to
23 chambers a paper copy of all electronically filed documents that exceed 50 pages in length, including
24 exhibits or attachments. Paper copies must be appropriately tabbed as stated in LR IA 10-3(i).

21 consenting to the granting of motion 101.
