The conduct of Defendant SAVANNAH RONFELDET was willful, intentional, and in disregard of and indifferent to Plaintiff’s rights, and such conduct caused harm to Plaintiff and deprived Plaintiff of income.

1. The Court hereby **AWARDS** statutory damages to the Plaintiff against Defendant SAVANNAH RONFELDET, in the amount of \$1,500.00 pursuant to 17 U.S.C. § 504.

2. The Court further **AWARDS** to the Plaintiff against Defendant SAVANNAH RONFELDET, fees and costs, including reasonable attorneys' fees, in the amount of \$6,217.50 pursuant to 17 U.S.C. § 505.
