(Second Request)

20 Plaintiff Gina M. Wofford (“Plaintiff”) filed a complaint alleging negligent and
21 willful violations of the Fair Credit Reporting Act against Defendant PHH Mortgage
22 Corporation (“PHH”). (ECF No. 1). PHH and Plaintiff previously agreed to extend the
23 time for PHH to respond to Plaintiff’s Complaint up to and including March 13, 2017.

3 pursuant to Federal Rule of Civil Procedure 26(f).
