11 Plaintiffs/Counter-Defendants US Bank National Association, as Trustee, Successor in
12 Interest to Wachovia Bank, National Association as Trustee for Wells Fargo Asset Securities
13 Corporation, Mortgage Pass-Through Certificates, Series 2005-AR2 at 4801 Frederica Street,
14 Owensboro, KY 42301 and Wells Fargo Bank, N.A. (jointly, “Plaintiffs”), and
15 Defendant/Counterclaimant Villa Vecchio Ct. Trust (“Villa Vecchio” and together with the
16 Plaintiffs, the “Parties”), through their counsel, for good cause shown, hereby stipulate and agree
17 to modify the briefing schedule set by LR 7-2(b) for the Parties’ forthcoming respective motions
18 for summary judgment. In support of this request, the Parties state the following:

19 1. On April 11, 2023, the Court issued its Minute Order setting a deadline of 60 days
20 within which to file dispositive motions. [ECF No. 98.]

21 2. The current deadline for the Parties to file their respective motions for summary
22 judgment is June 9, 2023. [ECF No. 98.]

23 3. On April 27, 2023, the Parties entered into a Stipulation and Order Modifying
24 Briefing Schedule on Dispositive Motions Pursuant to LR 7-2(b), extending the deadline for
25 filing oppositions and replies to their yet-to-be-filed respective motions for summary judgment.
26 [ECF No. 101.]

27 4. The current deadline to file motions for summary judgment is June 9, 2023, the
28 current deadline to file oppositions to the motions for summary judgment is July 7, 2023, and the
current deadline to file replies in support of the motions for summary judgment is July 28, 2023.

5. Good cause exists to grant a three-week extension for the Parties to file their
respective motions for summary judgment, oppositions, and replies due to scheduling difficulties

1 with immovable summer travel, which will abbreviate time for preparation of the various briefs
2 and client review.

3 NOW, THEREFORE, based on the foregoing and subject to Court approval, the Parties
4 agree as follows:

- 5 1. That the deadline to file motions for summary judgment shall be extended from
6 June 9, 2023 to **June 30, 2023**;
- 7 2. That the deadline for the Parties to file oppositions to the motions for summary
8 judgment shall be extended from July 7, 2023 to **July 21, 2023**; and
- 9 3. That the deadline for the Parties to file replies in support of the motions for
10 summary judgment shall be extended from July 28, 2023 to **August 18, 2023**.
