 24 On February 28, 2018 the Court held a hearing on Plaintiff’s Motion to Compel Complete  
 25 Responses to Plaintiff’s First Set of Interrogatives and First Set of Requests for Production (ECF  
 26 No. 30) (the “Motion”). During the hearing, the Court requested supplemental briefing to address  
 27 product numbers BC4010, BC3978, BC3836, BC3501, BC3930, , BC3868, BC3844 identified in  
 28 Plaintiff’s Reply Brief in support of Plaintiff’s Motion to Compel and product numbers BC3702,



1 BC3702-G and BC3928 which were unintentionally omitted from the products identified in  
2 Plaintiff's Reply Brief. Accordingly, the parties have stipulated to submit a joint brief addressing  
3 the matter. The parties agree that the brief will consist of no more than 5 pages per side, and will  
4 be filed by Friday, March 23, 2018. Plaintiff will provide its portion of the brief to Defendants by  
5 Friday, March 16, 2018 and Defendants will provide their portion back to Plaintiff by Thursday,  
6 March 22, 2018. Both sides will cooperate to revise, finalize and file the brief by Friday, March  
7 23, 2018.
