



1 amended in 2015 because it did not require HOAs to give notice to first-trust-deed holders. The  
2 Ninth Circuit panel in *Bourne Valley Court Trust v. Wells Fargo Bank* agreed.<sup>4</sup> The lynchpin of  
3 that holding is the panel’s interpretation of Chapter 116’s notice requirements: it found that the  
4 statute’s scheme was an opt-in one that required notice of the foreclosure “only if the lender had  
5 affirmatively requested notice,” expressly rejecting the notion that NRS Chapter 116  
6 incorporated the notice rules from NRS 107.090 so foreclosing HOAs “were required to provide  
7 notice to mortgage lenders even absent a request.”<sup>5</sup>

8         The Nevada Supreme Court expressly “declined to follow” *Bourne Valley* in *Saticoy Bay*  
9 *v. Wells Fargo* and held that “the Due Process Clauses of the United States and Nevada  
10 Constitutions are not implicated in an HOA’s nonjudicial foreclosure of a superpriority lien.”<sup>6</sup>  
11 But the *Saticoy Bay* decision turned on the absence of state action, so the court did “not  
12 determine whether NRS 116.3116 *et seq.* incorporates the notice requirements set forth in NRS  
13 107.090.”<sup>7</sup> The *Bourne Valley* purchaser petitioned for a writ of certiorari in the United States  
14 Supreme Court to resolve the federal-state split, but cert was denied.<sup>8</sup> So, this court is now  
15 bound to follow *Bourne Valley* unless and until the Nevada Supreme Court indicates that the  
16 panel’s interpretation of NRS 116.3116 was incorrect.<sup>9</sup>

17         That indication may be on its way. In accepting a certified question from Judge Boulware  
18 from this district, the Nevada Supreme Court has agreed to address the issue it shelved in *Saticoy*  
19 *Bay*:

1 Whether NRS § 116.31168(1)'s incorporation of NRS § 107.090  
2 required a homeowner's association to provide notices of default  
3 and/or sale to persons or entities holding a subordinate interest  
4 even when such persons or entities did not request notice, prior to  
5 the amendments that took effect on October 1, 2015?<sup>10</sup>

6 Briefing has been completed, and if the footnotes in the Nevada Supreme Court's recent  
7 unpublished orders are any indication, the answer will likely be yes.<sup>11</sup> So, to save the parties  
8 from the need or inclination to invest resources further briefing the effect of *Bourne Valley*  
9 before the Nevada Supreme Court has answered this certified question, I grant SFR's unopposed  
10 motion to stay,<sup>12</sup> stay all proceedings in this case pending the answer to the certified question,  
11 and deny SFR's pending motion to dismiss without prejudice to its ability to refile the motion  
12 after the stay is lifted.

### 11 Discussion

12 A district court has the inherent power to stay cases to control its docket and promote the  
13 efficient use of judicial resources.<sup>13</sup> When determining whether a stay is appropriate pending the  
14 resolution of another case—often called a “*Landis* stay”—the district court must weigh: (1) the  
15 possible damage that may result from a stay, (2) any “hardship or inequity” that a party may  
16 suffer if required to go forward, (3) “and the orderly course of justice measured in terms of the  
17 simplifying or complicating of issues, proof, and questions of law” that a stay will engender.<sup>14</sup>

1 SFR asks me to stay this case because “many issues in this case hinge upon the  
2 resolution of the Certified Question.”<sup>15</sup> I find that a *Landis* stay is appropriate here, so I grant  
3 SFR’s motion to stay.

4 **A. A stay will promote the orderly course of justice.**

5 At the center of this case is an HOA-foreclosure sale under NRS Chapter 116 and the  
6 competing arguments that the foreclosure sale either extinguished the bank’s security interest or  
7 had no legal effect because the statutory scheme violated the bank’s due-process rights. When a  
8 federal right depends on the interpretation of state law as this due-process challenge does, the  
9 federal courts must apply the interpretation of that law ascribed by the state’s highest court.<sup>16</sup>  
10 And when “the state’s highest court has not adjudicated the issue, a federal court must make a  
11 reasonable determination of the result the highest state court would reach if it were deciding the  
12 case.”<sup>17</sup> But that determination is just an educated guess of how the state’s highest court would  
13 interpret its law.<sup>18</sup> And a panel’s prediction binds lower courts only “in the absence of any  
14 subsequent indication” from the state’s highest court that the panel’s “interpretation was  
15 incorrect.”<sup>19</sup>

1 For *Bourne Valley*'s interpretation of NRS 116.3116, that "subsequent indication" may be  
2 nigh. The Nevada Supreme Court's acceptance of a certified question about its foundational  
3 statutory interpretation leaves the continued viability of *Bourne Valley* uncertain. Because that  
4 answer—which may be dispositive of the central issues in this case—is imminent, it makes  
5 judicially economical sense to wait for it before making dispositive rulings in this case. Each  
6 time the jurisprudence in this area of unique Nevada law evolves, the parties in the scores of  
7 foreclosure-challenge actions pending in this courthouse file new motions or move to supplement  
8 the ones that they already have pending, often resulting in docket-clogging entries and an  
9 impossible-to-follow chain of briefs in which arguments are abandoned and replaced. Staying  
10 this case pending the answer to the certified question will permit the parties to evaluate—and me  
11 to consider—the viability of the claims under the most complete authority. This will simplify  
12 and streamline the proceedings and promote the efficient use of the parties' and the court's  
13 resources.

14 **B. Hardship and inequity**

15 All parties face the prospect of hardship if I resolve the claims, motions, or issues in this  
16 case before the certified question is answered. A stay will prevent unnecessary briefing and the  
17 expenditures of time, attorney's fees, and resources that could be wasted in the event that *Bourne*  
18 *Valley*'s interpretation is deemed incorrect by the Nevada Supreme Court.

19 **C. Damage from a stay**

20 The only potential damage that may result from a stay is that the parties will have to wait  
21 longer for resolution of this case and any motions that they have filed or intend to file in the  
22 future. But a delay would also result from any rebriefing or supplemental briefing that may be  
23 necessitated once the Nevada Supreme Court answers the certified question. So it is not clear to  
24 me that staying this case pending the answer to that question will ultimately lengthen the life of  
25 this case. I thus find that any possible damage that this stay may cause the parties is minimal.

1 **D. The length of the stay is reasonable.**

2 Finally, I note that a stay of this case pending the anticipated answer to the certified  
3 question is expected to be reasonably short. Briefing in that case has been completed. Because  
4 the length of this stay is directly tied to the certified-question proceeding, it is reasonably brief,  
5 and it is not indefinite.

6 **Conclusion**

7 IT IS THEREFORE ORDERED that the Motion to Stay **[ECF No. 25] is GRANTED.**  
8 This case is stayed for all purposes. Once the Nevada Supreme Court has answered the certified  
9 question in *Bank of New York Mellon v. Star Hill Homeowners Association*, 2:16-cv-2561-RFB-  
10 PAL/Nev. S. Ct. Case No. 72931, any party may move to lift this stay.

11 IT IS FURTHER ORDERED that the Motion to Dismiss **[ECF No. 13] is DENIED**  
12 without prejudice to its refiling once the certified question has been answered and this stay has  
13 been lifted.
