3 COMES NOW Plaintiff/Counter-Defendant, U.S. Bank, National Association, as  
4 Trustee for C-BASS Trust 2006-CB9, C-BASS Mortgage Loan Asset-Backed Certificates,  
5 Series 2006-CB9 (hereinafter "U.S. Bank), Defendant/Counterclaimant/Cross-Claimant, SFR  
6 Investments Pool 1, LLC (hereinafter "SFR"), and Defendant, Rancho Las Brisas Master  
7 Homeowners Association (hereinafter "Rancho Las Brisas"), by and through their undersigned  
8 and respective counsel of record, hereby stipulate and agree as follows:

9 On October 25, 2017, Rancho Las Brisas filed its Motion for Summary Judgment [ECF  
10 No. 42], SFR filed its Motion for Summary Judgment [ECF No. 44], and U.S. Bank filed its  
11 Motion for Summary Judgment [ECF. No. 45].

12 On December 1, 2017, Rancho Las Brisas filed its Opposition to U.S. Bank's Motion for  
13 Summary Judgment [ECF No. 54], SFR filed its Opposition to U.S. Bank's Motion for  
14 Summary Judgment [ECF. No. 55], Rancho Las Brisas filed its Opposition to SFR's Motion for  
15 Summary Judgment [ECF No. 57], U.S. Bank filed its Opposition to Rancho Las Brisas HOA's  
16 Motion for Summary Judgment [ECF No. 58], and U.S. Bank filed its Opposition to SFR's  
17 Motion for Summary Judgment [ECF No. 60].

18 After the Parties filed their respective Oppositions to the pending Motions for Summary  
19 Judgment, the Court referred this matter to the Magistrate Judge for a settlement conference  
20 [ECF No. 61]. On December 8, 2017, and Order Scheduling a Settlement Conference for  
21 January 19, 2018, was issued [ECF No. 62].

22 On December 12, 2017, the Court granted a Stipulation and Order to Stay Litigation  
23 Pending Settlement Conference [ECF No. 64]. On January 19, 2018, the Parties participated in  
24 a settlement conference, which did not result in settlement [ECF No. 65]. Based thereon, the  
25 Parties wish to lift the stay and continue briefing the pending Motions for Summary Judgment.

26 **IT IS HEREBY STIPULATED AND AGREED** that the stay in this action is hereby  
27 LIFTED.
