**Order Denying Motion to Lift Stay and
Granting Countermotion to Extend Stay**

[ECF Nos. 27, 30]

11 Ocwen Loan Servicing, LLC filed this action to challenge a homeowners association's
12 (HOA's) non-judicial foreclosure sale of a home on which it held a first deed of trust, after the
13 Nevada Supreme Court held in *SFR Investments Pool 1, LLC v. U.S. Bank* that an HOA's proper
14 foreclosure under Nevada's statutory scheme "will extinguish a first deed of trust."¹ When a
15 federal-state split in the interpretation and effect of the statute arose, I stayed this case while the
16 factions pursued a writ of certiorari from the U.S. Supreme Court. Cert was denied, and Ocwen
17 now moves to lift that stay. But because an impending answer to a question certified to the
18 Nevada Supreme Court may soon resolve this split, SFR opposes the motion and countermoves
19 to extend the stay. I deny the motion to lift the stay, grant the countermotion, and extend the stay
20 pending the answer to the certified question.

21 **Background**

22 In the decade since Las Vegas's real estate crash, lenders and investors have battled over
23 the legal effect of an HOA's nonjudicial foreclosure of a superpriority lien on a lender's first trust
24 deed. After the Nevada Supreme Court held in *SFR* that a properly conducted foreclosure sale
25 extinguishes a first-trust-deed interest, the banks' emphasis shifted to their constitutional
26 challenge—they contend that the statute on its face violated their due process rights before it was

1 amended in 2015 because it did not require HOAs to give notice to first-trust-deed holders. The
2 Ninth Circuit panel in *Bourne Valley Court Trust v. Wells Fargo Bank* agreed.² The lynchpin of
3 that holding is the panel’s interpretation of Chapter 116’s notice requirements: it found that the
4 statute’s scheme was an opt-in one that required notice of the foreclosure “only if the lender had
5 affirmatively requested notice,” expressly rejecting the notion that NRS Chapter 116
6 incorporated the notice rules from NRS 107.090 so foreclosing HOAs “were required to provide
7 notice to mortgage lenders even absent a request.”³

8 The Nevada Supreme Court expressly “declined to follow” *Bourne Valley* in *Saticoy Bay*
9 *v. Wells Fargo* and held that “the Due Process Clauses of the United States and Nevada
10 Constitutions are not implicated in an HOA’s nonjudicial foreclosure of a superpriority lien.”⁴
11 But the *Saticoy Bay* decision turned on the absence of state action, so the court did “not
12 determine whether NRS 116.3116 *et seq.* incorporates the notice requirements set forth in NRS
13 107.090.”⁵

14 The *Bourne Valley* purchaser petitioned for a writ of certiorari in the United States
15 Supreme Court to resolve the federal-state split, but cert was denied.⁶ So, this court is now
16 bound to follow *Bourne Valley* unless and until the Nevada Supreme Court indicates that the
17 panel’s interpretation of NRS 116.3116 was incorrect.⁷

18 That indication may be on its way. In accepting a certified question from Judge Boulware
19 from this district, the Nevada Supreme Court has agreed to address the issue it shelved in *Saticoy*

1 Bay:

2 Whether NRS § 116.31168(1)'s incorporation of NRS § 107.090
3 required a homeowner's association to provide notices of default
4 and/or sale to persons or entities holding a subordinate interest
5 even when such persons or entities did not request notice, prior to
6 the amendments that took effect on October 1, 2015?⁸

7 Briefing is underway and is scheduled to be completed later this month. And if the footnotes in
8 the Nevada Supreme Court's recent unpublished orders are any indication, the answer will likely
9 be yes.⁹ So, to save the parties from the need or inclination to invest resources further briefing
10 the effect of *Bourne Valley* before the Nevada Supreme Court has answered this certified
11 question, I deny Ocwen's motion to lift my prior stay,¹⁰ grant SFR's countermotion,¹¹ and extend
12 that stay of all proceedings in this case pending the answer to the certified question.

11 Discussion

12 A district court has the inherent power to stay cases to control its docket and promote the
13 efficient use of judicial resources.¹² When determining whether a stay is appropriate pending the
14 resolution of another case—often called a “*Landis* stay”—the district court must weigh: (1) the
15 possible damage that may result from a stay, (2) any “hardship or inequity” that a party may
16 suffer if required to go forward, (3) “and the orderly course of justice measured in terms of the
17

1 simplifying or complicating of issues, proof, and questions of law” that a stay will engender.¹³
2 Ocwen asks me to lift the stay because the petition for certiorari in *Bourne Valley* was denied.¹⁴
3 SFR opposes that motion and countermoves to extend the stay.¹⁵ I find that a *Landis* stay
4 remains appropriate here, so I deny the motion to lift stay and grant the countermotion to extend
5 it.

6 **A. A stay will promote the orderly course of justice.**

7 At the center of this case is an HOA-foreclosure sale under NRS Chapter 116 and the
8 competing arguments that the foreclosure sale either extinguished the bank’s security interest or
9 had no legal effect because the statutory scheme violated the bank’s due-process rights. When a
10 federal right depends on the interpretation of state law as this due-process challenge does, the
11 federal courts must apply the interpretation of that law ascribed by the state’s highest court.¹⁶
12 And when “the state’s highest court has not adjudicated the issue, a federal court must make a
13 reasonable determination of the result the highest state court would reach if it were deciding the
14 case.”¹⁷ But that determination is just an educated guess of how the state’s highest court would
15 interpret its law.¹⁸ And a panel’s prediction binds lower courts only “in the absence of any

1 subsequent indication” from the state’s highest court that the panel’s “interpretation was
2 incorrect.”¹⁹

3 For *Bourne Valley*’s interpretation of NRS 116.3116, that “subsequent indication” may be
4 nigh. The Nevada Supreme Court’s acceptance of a certified question about its foundational
5 statutory interpretation leaves the continued viability of *Bourne Valley* uncertain. Because that
6 answer—which may be dispositive of the central issues in this case—is imminent, it makes
7 judicially economical sense to wait for it before making dispositive rulings in this case. Each
8 time the jurisprudence in this area of unique Nevada law evolves, the parties in the scores of
9 foreclosure-challenge actions pending in this courthouse file new motions or move to supplement
10 the ones that they already have pending, often resulting in docket-clogging entries and an
11 impossible-to-follow chain of briefs in which arguments are abandoned and replaced. Staying
12 this case pending the answer to the certified question will permit the parties to evaluate—and me
13 to consider—the viability of the claims under the most complete authority. This will simplify
14 and streamline the proceedings and promote the efficient use of the parties’ and the court’s
15 resources.

16 **B. Hardship and inequity**

17 All parties face the prospect of hardship if I resolve the claims or issues in this case
18 before the certified question is answered. A stay will prevent unnecessary briefing and the
19 expenditures of time, attorney’s fees, and resources that could be wasted in the event that *Bourne*
20 *Valley*’s interpretation is deemed incorrect by the Nevada Supreme Court.

21 **C. Damage from a stay**

22 The only potential damage that may result from a stay is that the parties will have to wait
23 longer for resolution of this case and any motions that they have filed or intend to file in the
24 future. But a delay would also result from any rebriefing or supplemental briefing that may be
25 necessitated once the Nevada Supreme Court answers the certified question. So it is not clear to

1 me that extending this stay pending the answer to that question will ultimately lengthen the life
2 of this case. I thus find that any possible damage that the extension of this stay may cause the
3 parties is minimal.


4 **D. The length of the stay is reasonable.**

5 Finally, I note that a stay of this case pending the anticipated answer to the certified
6 question is expected to be reasonably short. Briefing is scheduled to be completed in just a
7 couple of weeks. Because the length of this stay is directly tied to the certified-question
8 proceeding, it is reasonably brief, and it is not indefinite.

9 **Conclusion**

10 IT IS THEREFORE ORDERED that the Motion to Lift Stay [ECF No. 27] is **DENIED**,
11 and the Countermotion to Continue the Current Stay [ECF No. 30] is **GRANTED**. **The STAY**
12 **[ECF No. 26] is EXTENDED, and this case remains stayed for all purposes.**²⁰ Once the
13 Nevada Supreme Court has answered the certified question in *Bank of New York Mellon v. Star*
14 *Hill Homeowners Association*, 2:16-cv-2561-RFB-PAL/Nev. S. Ct. Case No. 72931, any party
15 may move to lift this stay.
