**STIPULATION AND ORDER TO
 CONTINUE HEARING ON
 DEFENDANT’S EMERGENCY MOTION
 TO VACATE ORDER FOR
 EXAMINATION OF JUDGMENT
 DEBTOR AND STAY PROCEEDINGS
 [DKT. 6]**

SECOND REQUEST

21 Judgment Creditor SMS Financial J, LLC (“SMS”) by and through its counsel of record
 22 Dylan T. Ciciliano, Esq. of the law firm Garman Turner Gordon, LLP, and SOUTHERN
 23 VEGAS VALLEY CONTRACTING, LLC (“SVVC”), by and through its counsel of record Jack
 24 Chen Min Juan, Esq. of the law firm Marquis Aurbach Coffing, hereby stipulate and agree as
 25 follows:

26 On or about March 20, 2017, SVVC filed its Emergency Motion to Vacate Order for
 27 Examination of Judgment Debtor and Stay Proceedings (the “Motion to Vacate”). [Dkt. 6]. By
 28 minute order dated March 21, 2017, the Court set a hearing on the Motion to Vacate for April 3,
 2017, and stayed the judgment debtor exam until the Court decides the Motion to Vacate. [Dkt.
 7].

The judgment that is the subject of the Motion to Vacate is based on an Order Granting
 Default Judgment (“Judgment”) in favor of KHI Liquidation Trust against SVVC in the United

1 States Bankruptcy Court of the Northern District of Illinois Eastern District, In re: Kimball Hill,
2 Inc., Case No. 08-10095, Adv. Proc. No. 10-00761 (the “Adversary Proceeding”), on or about
3 January 14, 2011. [See generally Dkt. 2].

4 Since the filing of the Motion to Vacate, SVVC and SMS engaged in settlement
5 discussions. Accordingly, the parties stipulated and agreed that the hearing on the Motion to
6 Vacate should be continued and the Court ordered that the Motion to Vacate be continued until
7 April 25, 2017. [Dkt 11].

8 SVVC and SMS continue to engage in settlement discussions. Currently, SVVC is
9 attempting to retrieve documents relevant to the underlying Adversary Proceeding. However,
10 given the age of the documents, their retrieval is time consuming. Accordingly, the parties
11 stipulate and agree that the hearing on the Motion to Vacate should be continued to May 22,
12 2017, subject to the Court’s availability, with any response to the Motion to Vacate being due on
13 May 15, 2017.

14 The parties further stipulate and agree that per the Court’s March 20, 2017, Minute Order
15 [dkt. 7], the judgment debtor exam should be stayed until such time that the Court decides the
16 Motion to Vacate.
