**STIPULATION AND ORDER TO STAY
ENTIRE CASE PENDING
SETTLEMENT**

(First Request)

1 Pursuant to Local Rules LR IA 6-2 and LR 7-1, Plaintiff/Counter-Defendant
2 JPMorgan Chase Bank, N.A. (“Chase”), Defendant/Counterclaimant/Cross-Claimant
3 SFR Investments Pool 1, LLC (“SFR”) and Defendant The Willows Homeowners’
4 Association (“The Willows”), through their respective attorneys, stipulate as follows:

5 1. On December 18, 2017, the Court entered an order extending the
6 discovery deadlines, which set the deadline to complete discovery for March 5, 2018
7 and the deadline to file dispositive motions for April 5, 2018. *See* ECF No. 53.

8 2. On March 7, 2017, the Court entered an order extending the dispositive
9 motion deadline to April 19, 2018 to allow the parties to take the deposition of The
10 Willows’ Rule 30(b)(6) designee outside the time to complete discovery. *See* ECF No.
11 55.

12 3. The Parties have since come to an agreement and are in the process of
13 finalizing settlement.

14 4. Given the resolution and to avoid wasting resources and incurring
15 potentially unnecessary expense associated with discovery, the Parties agree, and
16 hereby request, a stay of the case to give each side sufficient time and resources to
17 finalize settlement.

20 **ORDER**

20 **IT IS HEREBY ORDERED** that the parties' stipulation to stay the entire case is
