**STIPULATION AND ORDER
 REGARDING THE AMOUNT IN
 CONTROVERSY, AND REMAND TO
 STATE COURT**

17 It is hereby stipulated by and between Plaintiff MICHAEL EDWARD PATRON, through
 18 his attorney JUSTIN G. RANDALL, ESQ., of GLEN LERNER INJURY ATTORNEYS, and
 19 GEICO CASUALTY COMPANY, through its attorney ANDREW D. SMITH, ESQ., of ATKIN
 20 WINNER & SHERROD, that the Plaintiff does not now seek, and will not seek in the future,
 21 damages in excess of Fifty Thousand Dollars (\$50,000.00) by way of his Complaint in this
 22 matter for all causes of action, exclusive of attorney's fees, costs and interest, if any be allowed.

23 It is further stipulated that since the amount in controversy is less than \$75,000.00,
 24 exclusive of attorney's fees, costs and interest, the United States District Court for the District of
 25 Nevada lacks an element of jurisdiction required by 28 U.S.C. § 1332(a).

26 It is further stipulated that this case may be remanded to the Eighth Judicial District
 27 Court, Clark County, Nevada, based on this agreement as to the amount in controversy, and that
 28

1 each party shall pay its own attorney's fees and costs associated with the removal and remand.

14 **ORDER**

15 Based on the foregoing stipulation, IT IS HEREBY ORDERED that Plaintiff's total
16 recovery against Defendant GEICO Casualty Company by way of the Complaint in this matter
17 shall not exceed \$50,000.00 for all causes of action, exclusive of attorney's fees, costs and
18 interest, if any be allowed;

19 Therefore, THIS COURT FINDS that the amount in controversy does not exceed
20 \$75,000.00, which is the minimum threshold for federal district court jurisdiction per 28 U.S.C. §
21 1332(a); and

22 IT IS FURTHER ORDERED that this matter is REMANDED to the Eighth Judicial
23 District Court, Clark County, Nevada, by authority of 28 U.S.C. § 1447, each party to pay its
24 own attorney's fees and costs of suit associated with the removal and remand.
