1 Upon reading the Affidavit of Due Diligence; it appearing that an Answer, Counterclaim,
2 and Cross-Claim has been filed; that a Summons directed to Cross-Defendant, LORRAINE

12 prepaid, addressed to the Cross-Defendant's last known address.

13 **IT IS FURTHER ORDERED** that SFR's Motion to Enlarge Time to Serve is GRANTED
14 and the time for service is extended by an additional 60 days from the date of this order is entered
15 to allow SFR Investments Pool 1, LLC ("SFR") to effectuate service by publication.
