 20 Kevin Patimeteeporn, and Timothy Dorion ("LVMPD Defendants") by and through their  
 21 counsel, the law firm of Kaempfer Crowell, hereby stipulate and agree to extend the time for  
 22 Plaintiff to Respond to LVMPD Defendants' Motion for Reconsideration of the Court's Order  
 23 Denying Summary Judgment (ECF #117) filed on March 22, 2021.

 25 Accordingly, Plaintiff shall have up to and including May 5, 2021, to respond to LVMPD  
 26 Defendants' Motion for Reconsideration of the Court's Order Denying Summary Judgment

1 This request is submitted pursuant to LR IA 6-1, 6-2 and LR II 7-1 and is the parties first  
2 request for an extension of time for Plaintiff to respond to Defendant's Motion for  
3 Reconsideration of the Court's Order Denying Summary Judgment (ECF #117).

4 Good cause exists for this extension, as the current coronavirus/COVID-19 pandemic has  
5 caused, and continues to cause, disruption to the practices of counsel involved in this case. In  
6 addition, Plaintiff is incarcerated in High Desert State Prison and Plaintiff's Counsel has had  
7 difficulty communicating with him to formulate an opposition to Defendant's Motion for  
8 Reconsideration of the Court's Order Denying Summary Judgment.

10 Defendant has courteously granted this first request for an extension of time to file  
11 Plaintiff's Response. The extension will not prejudice any party and will allow Plaintiff to  
12 adequately brief its opposition to LVMPD Defendants' Motion for Reconsideration of the
