This matter comes before the Court upon motion made by ME2 PRODUCTIONS, INC. The conduct of Defendant SANDRA SANCHEZ was willful, intentional, and in disregard of and indifferent to Plaintiff’s rights, and such conduct caused harm to Plaintiff and deprived Plaintiff of income.

Upon this record, the Court adjudges and decrees as follows:

2. The Court further **AWARDS** to the Plaintiff against Defendant SANDRA SANCHEZ, fees and costs, including reasonable attorneys' fees, in the amount of \$5,048.75 pursuant to 17 U.S.C. § 505.
