15 IT IS HEREBY STIPULATED by and between Sandy Van, Esq., of Van Law Firm,
 16 attorneys for Plaintiff, Angelina Carson (hereinafter "Plaintiff"), and Kym Samuel Cushing, Esq. and
 17 Douglas M. Rowan, Esq. of Wilson, Elser, Moskowitz, Edelman & Dicker LLP, attorneys for
 18 Defendant Target Corporation (hereinafter "Defendant"), that as the total value of damages in this
 19 action does not exceed this Court's required amount of SEVENTY-FIVE THOUSAND DOLLARS
 20 and NO CENTS (\$75,000.00) necessary to maintain subject matter jurisdiction in this court, this
 21 case shall be REMANDED to the Eighth Judicial District Court of Clark County, Nevada for all
 22 further proceedings.

23 IT IS FURTHER STIPULATED between the parties that the total amount of damages which
 24 Plaintiff seeks to recover in this action will not exceed SEVENTY-FIVE THOUSAND DOLLARS
 25 (\$75,000.00).


26 IT IS FURTHER STIPULATED that Plaintiff WAIVES any right to collectively recover any

 28 against Defendant, resulting from the incident that occurred on November 27, 2015.





13 stipulated by the parties set forth herein.


14 IT IS FURTHER HEREBY ORDERED that pursuant to the agreement of the parties, the
