SHIH ("Shih"); SMM Capital LLC ("SMM"); and BIN ZHANG 11 ("Zhang" and collectively with Premier One, Shih and SMM as "Defendants") as follows: 12 IT IS HEREBY ORDERED, ADJUDGED, AND DECREED that Judgment is hereby 13 entered in favor of BNYM against the Defendants on BNYM's quiet title and declaratory relief 14 claims. 15 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the Deed of Trust 16 recorded on October 26, 2004 in the official records of Clark County Recorder's Office as Book 17 and Instrument Number 20041026-0004778 ("BNYM Deed of Trust") still encumbers the 18 Property, and that the Deed of Trust was not extinguished by the HOA Sale held on April 16, 19 2013, whereby the Premier One purportedly acquired its interest in the Property; 20 IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that BNYM Deed of 21 Trust is senior in priority to any interest held by Defendants, Shih, SMM and Zhang pursuant to 22

the Deeds of Trust recorded in the official records of Clark County Recorder's Office as Book and Instrument Numbers 201305310004365 and 201611290001457 following the HOA Sale;

IT IS FURTHER ORDERED, ADJUDGED, AND DECREED that the BNYM Deed of Trust is superior to the interest of the Defendants, including any of their successors and assigns, in the Property;
