 20 WHEREAS, Plaintiff THE BANK OF NEW YORK MELLON FKA THE
 21 BANK OF NEW YORK AS TRUSTEE FOR THE CERTIFICATEHOLDERS OF
 22 THE CWABS, INC. ASSET-BACKED CERTIFICATES, SERIES 2005-11
 23 (“BNYM”); Defendant SHADOW SPRINGS COMMUNITY ASSOCIATION
 24 (“Shadow Springs”); and Defendant VEGAS PROPERTY SERVICES, INC. (“Vegas
 25 Property”) reached an agreement to allow Shadow Springs and Vegas Property




