**STIPULATION AND

[FOURTH REQUEST]

11 Plaintiff KEVIN ZIMMERMAN (hereinafter "Plaintiff") and Defendant WAL-MART
12 STORES, INC., (hereinafter, "Defendant") by and through their undersigned counsel, hereby agree
13 and stipulate to extend the time for Defendant to file a response to the Plaintiff's Complaint from the
14 current deadline of July 24, 2017 up to and including **August 14, 2017**.

11 The parties' counsel met on June 9, 2017 and reached a settlement, the general terms of
12 which have since been confirmed in an email. At this time, a response to the complaint is
13 unnecessary because this matter will be dismissed after the settlement is executed. Accordingly, the
14 parties request that this stipulation be granted.

11 The settlement agreement should be finalized on July 21st and will thereafter be exchanged
12 for signature. The parties believe the settlement will be finalized in the next two weeks, but have
13 requested this 28 day extension out of an abundance of caution to ensure sufficient time to resolve
14 any potential wording issues with the settlement agreement.

1 This is the fourth request for an extension of time to respond to the Complaint. This request
2 is made in good faith and not for the purpose of delay.
