7 that Respondent and Respondent's affiliates have held or claimed an interest in and that  
8 was the subject of an HOA foreclosure completed under Nevada Revised Statute §  
9 116.3116 between September 18, 2009 and the present.

10 2. Respondent shall not be required at this time to provide the Petitioner with any other  
11 information requested in the subpoena.
