

1. This is a quiet title action arising from an HOA foreclosure sale (the
 "Sale") of a residential property located at 8045 Astrology Court Unit 101, Las Vegas,
 Nevada 89128 (the "Property").

2. Plaintiff originally brought this matter in the Eighth Judicial District Court
of Nevada (A-17-752728-C).

6 3. Defendant Nationstar was served with the Complaint and removed this7 matter to Federal Court.

8 4. On May 25, 2017 Plaintiff filed a Motion to Remand (ECF No. 10), which
9 would fully remove this matter from this Court if granted.

5. Whether this matter is brought in state or federal court would affect the
applicable law resulting in a potential waste of judicial resources as well as the resources
of both parties from engaging in discovery if remanded.

6. The Parties request a stay of litigation until this Court has ruled on the pending Motion to Remand as it would be dispositive of this action in this Court.

7. The Parties agree to submit a renewed discovery schedule within 30 days of this Court's ruling in the event this matter is not remanded.
