 19 IT IS HEREBY STIPULATED, by the parties, through their respective counsel of record, that
 20 the time for responding to Plaintiff's Motion for Reversal and/or Remand be extended for one week
 21 from January 17, 2018 to **January 24, 2018**. This is Defendant's third request for extension. Good
 22 cause exists to grant Defendant's request for extension. Counsel is taking leave, including on the date
