21 **ORDER**

22 Local Rule 7-1(c) states that “A stipulation that has been signed by fewer than all the parties or their
23 attorneys will be treated—and must be filed—as a joint motion.” This stipulation [ECF No. 26] is between
24 the plaintiff and only one of the three remaining defendants in this case. Accordingly, I treat it as a joint
25 motion under LR 7-1(c), find good cause, and GRANT it [ECF No. 26]. IT IS THEREFORE ORDERED
26 that all claims against defendant Trans Union, LLC are DISMISSED with prejudice, each party to bear its
27 own fees and costs.
