1           4.       The Parties request additional time to make their respective additional disclosures  
2 and request an extension until July 7, 2017.

3           5.       The reason for the request is primarily a result of MLHL’s counsel being unable  
4 to access the database established by MLHL containing MLHL’s relevant documents prior to the  
5 current due date for initial disclosures due to a technical issue.

6           6.       While access has been granted as of June 27, 2017, MLHL’s counsel needs  
7 additional time to review the documents prior to disclosure.

8           7.       In order to accommodate schedules of the Parties, their respective attorneys and  
9 the upcoming July 4th holiday, the Parties request an extension until July7, 2017.

10          8.       This stipulation is not being made for purposes of delay.

11          9.       Therefore, the Parties agree that the Parties’ initial disclosures are now due on or  
12 before **July 7, 2017**.


