**ORDER GRANTING MOTION TO LIFT
 STAY [ECF No. 27]**

23 Plaintiff James W.P. Andrews (“Plaintiff”) hereby moves this Court to lift the
 24 Stay in this case. On July 12, 2017 this Court granted Defendant’s motion to stay
 25 this case pending the D.C. Circuit’s issuance of a mandate in *ACA Int’l v. FCC*, No.
 26 15-1211 (D.C. Cir. 2015). ECF No. 17. The D.C. Circuit issued its decision on
 27 March 16, 2018. *ACA Int’l v. FCC*, No. 15-1211, 2018 U.S. App. LEXIS 6535
 28 (D.C. Cir. Mar. 16, 2018). Plaintiff therefore requests that the Stay be lifted in this
 case.

1 Plaintiff will meet and confer with Defendant and file a joint proposed
2 discovery plan and scheduling order within **14 days** after this Court grants this
3 motion, or as otherwise directed by this Court.
