29 Plaintiff James W.P. Andrews (“Plaintiff”) and Ocwen Loan Servicing, LLC
 30 (“Defendant”), by and through their respective counsel, hereby submit this
 31 stipulation for an extension of time—until **June 11, 2018**—for Plaintiff to respond
 32 to Defendant’s Motion to Dismiss Plaintiff’s First Amended Complaint, filed on
 33 May 14, 2018, ECF No. 29. Plaintiff’s Response is currently due on May 28, 2018.

34 Plaintiff filed his Complaint on May 5, 2017. ECF No. 1. On July 12, 2017

1 this Court granted Defendant's motion to stay this case pending the D.C. Circuit's
2 issuance of a mandate in *ACA Int'l v. FCC*, No. 15-1211 (D.C. Cir. 2015). ECF No.
3 17. The Stay was lifted on April 23, 2018. ECF No. 28. The Parties are actively
4 discussing possible mediation in this case. In good faith and not for the purposes of
5 delay, Plaintiff has requested and Defendant has agreed to allow Plaintiff an
6 additional 14 days to respond to the Motion. The Parties in good faith stipulate to
7 allow additional time for Plaintiff to respond to the Motion. This is the first request
8 for an extension of this deadline.

9 The Parties therefore stipulate that Plaintiff's response to Defendant's motion
10 to dismiss, ECF. No. 29, shall be due on or before **June 11, 2018**.


