1 Plaintiff Hailesslassie Godifay hereby moves the Court for an extension of  
2 time by seven (7) days from June 29, 2017 to July 6, 2017, for Plaintiff to pay the  
3 \$350.00 filing fee, plus the \$50.00 administrative fee, or an amended application to  
4 proceed in forma pauperis.

5 The Court denied Plaintiff's application to proceed in forma pauperis on  
6 May 30, 2017 due to what appeared to be a total monthly income of \$7,000.00.  
7 Plaintiff informed Counsel that this was incorrect as the approximately \$7,000.00  
8 came in the form of two loans, against a separate lawsuit, over the course of  
9 several months, rather than a monthly income. Counsel requested that Plaintiff  
10 provide Counsel with all evidence related to the loans, including information  
11 related to the liens, in order to ensure complete accuracy in any amended  
12 application to proceed in forma pauperis. Plaintiff has provided Counsel with all  
13 but one document, which Plaintiff has requested and anticipates receiving within  
14 seven (7) days. Plaintiff respectfully requests more time to pay the filing fee or file  
15 an amended application to proceed in forma pauperis.

16 Counsel sincerely apologizes to the Court for any inconvenience this request  
17 may have caused.


