16 **STIPULATION AND ORDER TO EXTEND TIME TO FILE REPLY IN SUPPORT OF**
 17 **MOTION TO ALTER OR AMEND JUDGMENT [ECF NO. 50]**

18 Plaintiff The Bank of New York Mellon fka The Bank of New York as Trustee for the
 19 Benefit of the Certificate Holders of the CWALT, Inc., Alternative Loan Trust 2004-J09, Mortgage
 20 Pass Through Certificates, Series 2004-J09 (**BoNYM**), Defendants Ron Haus and Eva Berou (**Haus,**
 21 **Berou**) and Defendant Painted Desert Community Association (**HOA**) stipulate as follows:

22 1. BoNYM filed its motion to alter or amend judgment, on September 26, 2018. [ECF
 23 No. 50]. Haus, Berou filed its response to BoNYM’s motion on October 10, 2018 [ECF No. 52].
