**STIPULATION AND ORDER TO  
 EXTEND DISCOVERY AND  
 DISPOSITIVE MOTION  
 DEADLINES**  
**(First Request)**

22 The parties, by and through their respective counsel of record, hereby stipulate and agree as  
 23 follows:

- 24 1. On January 8, 2018, this Court entered an Order granting the Stipulated Discovery  
 25 Plan and Scheduling Order submitted by the parties.
- 26 2. This is the first request by the parties to amend the Court's January 8, 2018  
 27 Scheduling Order.
- 28 3. The parties stipulate and agree to extend the discovery and expert disclosure  
 deadlines for sixty (60) days to allow the parties to coordinate multiple schedules and conduct  
 necessary depositions in order to fully evaluate the claims and defenses presented.



1           4.       **Pre-Trial Order**: If no dispositive motions are filed, the Joint Pretrial Order shall  
2 be filed thirty (30) days after the date set for the filing of dispositive motions. Therefore, the Joint  
3 Pretrial order shall be filed no later than October 24, 2018. In the event dispositive motions are  
4 filed, the date for filing the Joint Pretrial Order shall be suspended until thirty (30) days after  
5 decision on the dispositive motions or by further order of the Court.

6           This stipulation and order is sought in good faith and not for the purpose of delay. No prior  
7 request for any extension of scheduling deadlines has been made.


