20 Defendants HSBC Bank USA, N.A., as trustee for Wells Fargo Home Equity Asset-Backed
 21 Certificates, Series 2006-3, by its Attorney-in-fact Wells Fargo Bank, N.A., Wells Fargo Bank,
 22 N.A., and Wells Fargo Asset Securities Corporation (collectively, “Defendants”) and Plaintiff
 23 Edyta Gryglak (“Plaintiff” and together with Defendants, the “Parties”) hereby stipulate to extend
 24 the briefing schedule on Defendants’ Motion for Summary Judgment [ECF 45] as follows:

- 25 (i) the due date for Plaintiff’s opposition papers shall be extended by
 26 one week, from October 18, 2018 to October 25, 2018; and
- 27 (ii) Defendants’ time to file reply papers shall be extended from 14 days
 28 to 21 days, which shall make the due date for Defendants’ reply
 papers November 15, 2018.

WHEREAS Defendants filed their Motion for Summary Judgment on September 13, 2018;

1 WHEREAS the Court previously granted the parties first Stipulation and Order extending
2 Plaintiffs due date to file opposition papers by two weeks, from October 4, 2018 to October 18,
3 2018;

4 WHEREAS the first extension was necessary due to the hospitalization of Plaintiff's
5 counsel;

6 WHEREAS since returning to work, Plaintiff's counsel has had an intense work schedule,
7 including a mediation in Florida, a site-inspection in Michigan, an Eleventh Circuit appellate brief,
8 and discovery motions and responses in cases pending in Louisiana, California, and New York;

9 WHEREAS Plaintiff's counsel needs an additional week to complete and file Plaintiffs'
10 opposition papers, which would extend the due date for opposition papers to October 25, 2018; and

11 WHEREAS Defendants' counsel needs to extend the period to prepare reply papers by one
12 week, *i.e.*, from two weeks to three weeks, in light of previously scheduled matters during the two-
13 week period between October 25, 2018 and November 8, 2018;

14 **THE PARTIES HEREBY STIPULATE:**

15 1. The briefing schedule on Defendants' motion for summary judgment is extended as
16 follows:

- 17 (i) Opposition papers are due on October 25, 2018;
- 18 (ii) Reply papers are due on November 15, 2018.
