**FOURTH STIPULATION AND ORDER
 EXTENDING SUMMARY JUDGMENT
 BRIEFING SCHEDULE**

(Fourth Request)

20 Defendants HSBC Bank USA, N.A., as trustee for Wells Fargo Home Equity Asset-Backed
 21 Certificates, Series 2006-3, by its Attorney-in-fact Wells Fargo Bank, N.A., Wells Fargo Bank,
 22 N.A., and Wells Fargo Asset Securities Corporation (collectively, “Defendants”) and Plaintiff
 23 Edyta Gryglak (“Plaintiff” and together with Defendants, the “Parties”) hereby stipulate to extend
 24 the briefing schedule on Defendants’ Motion for Summary Judgment [ECF 45] as follows:

- 25 (i) the due date for Plaintiff’s opposition papers shall be extended by
 26 two business days, from Thursday November 8, 2018 to Tuesday,
 27 November 13, 2018; and
- 28 (ii) Defendants’ time to file reply papers be three weeks later, on
 December 4, 2018.

WHEREAS Defendants filed their Motion for Summary Judgment on September 13, 2018;

WHEREAS the Court previously granted the parties’ First, Second, and Third Stipulations
 and Orders, which extended Plaintiff’s due date to file opposition papers by a total of five weeks,

1 from October 4, 2018 to November 8, 2018, and extended Defendants' response time from two
2 weeks to three weeks;

3 WHEREAS the first, second, and third extensions were necessary due to the hospitalization
4 of Plaintiff's counsel and his intense work schedule upon returning to work;

5 WHEREAS Plaintiff counsel's work scheduled has continued to be unusually intense,
6 including, in addition to the matters described in the prior stipulations, preparing for a November
7 15, 2018 trial in Nevada state court and a December 4, 2018 trial in the United States District Court
8 for the Eastern District of Michigan;

9 WHEREAS Plaintiff's opposition papers are now almost complete, but Plaintiff counsel
10 needs two additional business days to complete and file them;

11 **THE PARTIES HEREBY STIPULATE:**

12 1. The briefing schedule on Defendants' motion for summary judgment is extended as
13 follows:

- 14 (i) Opposition papers are due on November 13, 2018;
15 (ii) Reply papers are due on December 4, 2018.


