

1 officer, John Sabatini, “for the purposes of discovery and dispositive motions” and with “the
2 option at a later time to consolidate for the purposes of trial, if needed.”³

3 After extensive briefing, I granted summary judgment for the defense on all of Moser’s
4 claims and some of Sabatini’s claims.⁴ Sabatini ultimately dismissed his suit,⁵ but Moser
5 appealed. Earlier this year, the Ninth Circuit, in a published opinion, reversed and remanded,
6 finding that factual disputes “about the objective meaning of Moser’s comment” and its effect
7 should have precluded summary judgment on his claims.⁶

8 Moser now moves to transfer this case back to U.S. District Judge Andrew Gordon, who
9 was originally assigned the case before it was consolidated with Sabatini’s.⁷ He notes that
10 consolidation was sought only to “obtain the benefit of the expertise of Sabatini’s counsel,” who
11 “held himself out as a First Amendment specialist.”⁸ I construe this motion as one for
12 deconsolidation. Because there is no longer a case to keep Moser’s consolidated with and the
13 limited scope and purpose of consolidation (discovery and dispositive motions) have been
14 satisfied,



24 have likely caused disruption in the police department. These factual disputes had to be resolved
25 before the court could weigh the competing considerations under the *Pickering* [*v. Board of*
Education, 391 U.S. 563 (1968)] balancing test. We thus reverse the grant of summary judgment
26 and remand.”).

1 IT IS HEREBY ORDERED that Moser's Motion to Transfer [ECF No. 75] is
2 **GRANTED. The Clerk of Court is directed to DECONSOLIDATE this action and reopen**
3 **Case No. 2:17-cv-1704-APG-NJK.** All future filings in Moser's case should be in Case No.
4 2:17-cv-1704-APG-NJK. And because there remain no claims pending in the Sabatini case, the
5 Clerk of Court is directed to **CLOSE** Case No. 2:17-cv-01012-JAD-NJK.
