6. On May 4, 2019, Plaintiff filed his response to the Motion for Reconsideration.

7. On May 20, 2019, Defendant filed its reply in support of the Motion for Reconsideration [ECF No. 81].

9 8. The Parties have engaged in settlement conversations, although a settlement has
10 not been reached. The parties continue to discuss potential resolution.

9. Counsel for SLS is scheduled to begin trial the second week of August, and potentially will have another trial scheduled for the first or third week of November. Counsel for Plaintiff has a trial presently scheduled to begin on November 12, 2019, which should last several days.

15 10. The parties have met and conferred via email on the pretrial deadline. SLS believes 16 that the issues raised in the Motion for Reconsideration may substantially impact the issues to be 17 decided at trial, and to allow the Court an opportunity to consider the motion and any oral argument 18 heard, it is the best interests of the parties and judicial economy to continue the deadline to submit 19 a Joint Pretrial Order from October 14, 2019 to November 22, 2019. As noted in Plaintiff's 20 opposition to SLS's Motion for Reconsideration, Plaintiff believes that reconsideration should be 21 denied, such that adjudication on the Motion will not limit the issues remaining for trial. 22 Regardless, Plaintiff has no objection to an extension of the pretrial deadlines. Therefore, the 23 parties are in agreement that an extension is warranted.
