[FIRST REQUEST]

26 WHEREAS, on June 30, 2017, Petitioner filed an application for enforcement of a

1 subpoena issued by a federal administrative agency; and

2 WHEREAS, on July 10, 2017, Respondent provided Petitioner with documents that
3 Respondent represents are responsive to the subpoena.

4 NOW THEREFORE, based upon the foregoing, Petitioner and Respondent, by and
5 through their respective counsel, stipulate to extend the deadline for Respondent to respond to
6 Petitioner's Application of Order Requiring Compliance with Subpoena Duces Tecum from July

9 subpoena, thus obviating the need to pursue these subpoena enforcement proceedings further.
