25 Plaintiff KEITH BROWN (“Plaintiff”), by and through his undersigned counsel,
 26 and pursuant to Federal Rules of Civil Procedure (“FRCP”) Rule 6(b)(1), hereby requests
 27 an enlargement of time for non-resident counsel to file a Verified Petition and Motion for
 28 Permission to Practice in This Case Only (“*Pro Hac Application*”).

MEMORANDUM OF POINTS AND AUTHORITIES

1
2 FRCP 6(b)(1) provides, in pertinent part, that “[w]hen an act may or must be done
3 within a specified time, the court may, for good cause, extend the time... if a request is
4 made, before the original time or its extension expires.” On July 10, 2017, this Court
5 ordered all non-resident counsel to file *Pro Hac* Applications by August 24, 2017. [ECF
6 No. 50]. This request is therefore being made before the original time expires and, as
7 discussed below, good cause exists for granting Plaintiff’s request.

8 Non-Resident counsel for Plaintiff, John Ryan Gustafson, Esq., of the law firm
9 Gustafson Nicolai pc, has agreed in principle to associate with the Nevada law firm
10 Holley Driggs Walch Fine Wray Puzey & Thompson as local counsel in this action. This
11 case was recently transferred to this Court from the United States District Court for the
12 Southern District of California. Attorney Gustafson has been counsel of record for
13 Plaintiff in the case since its inception and is awaiting the forwarding of his required
14 certificate of good standing from the State Bar of California. Plaintiff therefore believes
15 good cause exists to grant this short extension to allow Plaintiff’s non-resident counsel to
16 file his *Pro Hac* Application.
