Successor Trustee to Bank of America, N.A., Successor in Interest to LaSalle Bank N.A., on Behalf of The Registered Holders of Bear Stearns Asset Backed Securities I LLC, Asset-Backed Certificates, Series 2006-HE6 (the “Trust”) to respond to Treasures Landscape Maintenance Association’s Motion to Dismiss, or in the Alternative, Motion for Summary Judgment (Dkt. 18), and Defendant, Terrafirma Venture LLC’s Motion to Dismiss Plaintiff’s Complaint (Dkt. 19) (collectively, the “Motions to Dismiss”), both of which were filed November 27, 2017. 
