| 15 | I. DISCUSSION |
| 16 | According to the Federal Bureau of Prisons' inmate database, Plaintiff is no longer |
| 17 | incarcerated. However, Plaintiff has not filed an updated address with this Court. The |
| 18 | Court notes that pursuant to Nevada Local Rule of Practice IA 3-1, a "pro se party must |
| 19 | immediately file with the court written notification of any change of mailing address, email |
| 20 | address, telephone number, or facsimile number. The notification must include proof of |
| 21 | service on each opposing party or the party's attorney. Failure to comply with this rule |
| 22 | may result in the dismissal of the action, entry of default judgment, or other sanctions as |
| 23 | deemed appropriate by the court." Nev. Loc. R. IA 3-1. This Court grants Plaintiff thirty |
| 24 | (30) days from the date of entry of this order to file his updated address with this Court. |
| 25 26 | If Plaintiff does not update the Court with his current address within thirty (30) days from |
| 20 27 | the date of entry of this order, the Court will dismiss this action without prejudice. |
| 28 | Additionally, the Court denies the application to proceed in forma pauperis for |
| 20 | prisoners (ECF No. 4) as moot because Plaintiff is no longer incarcerated. The Court |
