35 The Bank of New York Mellon f/k/a the Bank of New York as Trustee for the
36 Certificateholders of CWABS, Inc., Asset Backed Certificates, Series 2005-BC2 (**BoNYM**), and
37 Washington & Sandhill Homeowners Association (**Washington**), and Absolute Collection Services,
38 LLC (**ACS**), hereby stipulate and agree that BoNYM shall either have an additional sixty (60) days,
39 up to and including **June 7, 2018**, to file its response to ACS' motion to dismiss complaint and
40 Washington's motion to dismiss, which are currently due on April 7, 2018, pursuant to ECF No. 46,

1 or until after the court rules on the requests to enter default against CSC Acquisition & Holding
2 Group [ECF No. 47], LLC and EQ Partners Solutions, LLC [ECF No. 48].

3 The granting of these motions for default judgments is likely to complete this case and result
4 in the dismissal of the ACS and Washington. The parties request the extension in order to avoid
5 incurring additional costs during that time.
