**MOTION FOR SANCTIONS FOR PLAINTIFF'S UNTIMELY CANCELLATION**  
**OF A RULE 35 MENTAL EXAMINATION (FIRST REQUEST)**

25 Hudgins, Gunn & Dial, LLC and hereby file this stipulation to extend time for Plaintiff to respond  
26 to Defendant Motor Coach Industries, Inc.'s Motion to Set The Rule 35 Psychiatric Examination  
27 of Plaintiff, filed on October 9, 2018 and Motion for Sanctions for Plaintiff's Untimely  
28 Cancellation of a Rule 35 Mental Examination, filed on October 12, 2018. Pursuant to previous

1 Orders of this Court, the deadline to file the responses are October 23, 2018 and October 26,  
2 2018, respectively.
