14 BoNYM filed stipulation and order to extend time to respond to HOA’s motion for summary
15 judgment on June 6, 2016 [ECF No. 31]. BoNYM’s response is currently due on June 20, 2018.

16 5. The parties hereby stipulate and agree that BoNYM, HOA, and Trust shall have until
17 **July 6, 2018** to file their replies in support of motions for summary judgment.


