25 **JOINT STIPULATION OF SUBSTITUTION**

26 NOW COME the parties in this action, Plaintiff Michele Joseph and Defendant, Desert
 27 Rock Enterprises II, LLC, by and through their undersigned counsel, to hereby stipulate as
 28 follows:


1. In this action, Plaintiff Michele Joseph alleges that the “The D Las Vegas” located
 at 301 Fremont St, Las Vegas, NV 89101 is not accessible to individuals with disabilities.

1 2. In the Complaint, Plaintiff has incorrectly identified Defendant Desert Rock
2 Enterprises II, LLC as the owner of the "The D Las Vegas". The D Las Vegas is in fact owned
3 by DROCK Gaming, LLC, a Nevada limited liability company.

4 3. The parties jointly stipulate that DROCK Gaming, LLC shall be substituted as a
5 defendant in this case for Defendant Desert Rock Enterprises II, LLC, and that Defendant Desert
6 Rock Enterprises II, LLC shall be dismissed from the case with prejudice. The parties also
7 jointly stipulate that all references in the Complaint to Desert Rock Enterprises II, LLC shall be
8 construed as references to DROCK Gaming, LLC.

10 4. Pursuant to Rule 4(d) of the Federal Rules of Civil Procedure, DROCK Gaming,
11 LLC hereby waives service of the summons in this action.
