25 Pursuant to Local Rules IA 6-1 and 6-2, Plaintiff Cristine L. Blackman
 26 (“Plaintiff”) and Defendant Ocwen Loan Servicing, LLC (“Ocwen”) hereby stipulate to
 27 extend the deadline for Ocwen to respond to the Complaint from November 27, 2017
 28 through and including December 11, 2017. This is the third extension sought by Ocwen.
 Ocwen seeks this extension in good faith in order to allow it time to adequately
 investigate the allegations in the Complaint and for the parties to explore whether an


